Omega-3 Supra-1000 mg Capsules

1000 mg of fish oil, 300 mg EPA, 200 mg DHA Dietary supplement with fish oil, folic acid, vitamin B1, B6, B12, and E

Good to know: Each capsule contains **1000 mg of fish oil** with a particularly high content of omega-3 fatty acids of more than 60 percent. An important source of the omega-3 fatty acids are **DHA** (docosahexaenoic acid, min. 20%) and **EPA** (eicosapentaenoic acid, min. 30%), which have been proven to **contribute to a normal heart function** (starting from a daily intake of 250 mg). Folic acid and the vitamins B1, B6, B12 and E have a supporting effect. Folic acid **normalizes homocysteine levels**. Vitamin B1 - also known as thiamine - contributes to **normal cardiac function**. The vitamins B6 and B12 help the body produce red blood cells, which carry oxygen to all parts of the body. Vitamin E helps protect cells against oxidative stress.

Ingredients: Fish oil, Gelatin, humectant Glycerin, thickener Silicon Dioxide, Vitamin E, filler Sunflower Oil, Vitamin B6 Hydrochloride, Vitamin B1 Mononitrate, Folic Acid, Vitamin B12.
